1. Name of Programme

BA (Hons) in Theology, Ministry and Mission

AIMS AND LEARNING OUTCOMES

2. Educational and Formational Aims

The educational and formational aims of the programme are described in terms of the people for whom it is designed, the pedagogy it embodies and the purpose it is intended to fulfil.

People

The aim of this programme is to equip Christian disciples and ministers to develop as competent and faithful reflective practitioners. To this end it provides an education in theology, ministry and mission in and for a variety of contexts.

1. Preparing people for professional ministry and mission within churches:

Many students will be preparing for recognised lay and ordained ministries in the Anglican, Methodist, Baptist and United Reformed churches. Others will be engaging in the programme as part of their professional development. The programmes serve institutions representing Anglican, Methodist, United Reformed, Baptist, Roman Catholic and Orthodox churches, as well as being open to students from other denominations.

2. Preparing people for lay ministry and mission in the world:

The programme also serves those who wish to be more fully equipped for Christian life and service in the world, or simply more informed about the Christian faith. Within this category, some students will be preparing for ministry and mission among children and young people within and beyond ecclesial structures. Typically, students will be preparing for service in third sector and statutory organisations as well as in churches.

The programme aims to offer education that is accessible to students with a wide range of educational backgrounds and professional and personal circumstances: many will be mature students, many will be employed and therefore studying part time, many will be in active ministry, while still others will be pursuing the programme as full-time residential students. The programme will therefore be available in a variety of modes of learning and teaching, including traditional full time residential learning, part time and part residential learning, and distance learning supported by online and face to face engagement.

Pedagogy

The aim of this programme is to provide an education in theology, ministry and mission that encompasses the development of character and the nurturing of virtues and spirituality alongside the acquisition of knowledge and understanding, and the development of cognitive and practical skills. The programme aims to enable students to engage more deeply with

themselves, others, the church, the world and God by offering learning and teaching that:

1. form students in various disciplines, but bring those disciplines together to inform and enrich one another;
2. are constantly oriented towards the ministry and mission for which students are being prepared; and
3. by their modes of assessment and methods of learning and teaching enable students to develop as lifelong reflective learners.

Purpose

The purpose of the programme is to offer personal and professional preparation for a range of Christian ministries as well as to satisfy the aspirations of those students who undertake their studies to enhance, broaden and deepen their discipleship and ministry in other contexts.

From a professional point of view, the aim of the programme is to

1. offer pathways of study that contribute to meeting the range of professional and vocational criteria for the public ministries for which students are being prepared;
2. satisfy the aspirations of those students who undertake their studies to enhance, broaden and deepen their discipleship and ministry in other contexts; and
3. provide a firm basis from which to pursue further study in theology, ministry and mission at postgraduate level.

From a personal perspective, the aim of this programme is to develop dispositions that are congruent with, and necessary for, Christian ministry and mission in the church and the world. The aims of the programme are that learners completing the programme will have become

1. open to the questions, insights and ongoing formation generated by attentive study of Scripture, and be willing to go on being transformed by them;
2. aware of the skills and disposition needed to go on reading themselves, the church and the world in the light of Christian doctrine, and to explore Christian doctrine more deeply in the light of experience and practice;
3. deeply aware that they are heirs to a long and complex history, aware of their place in that history alongside many others, and attuned to the work of the Holy Spirit in the church and the world through history and in the present;
4. passionate and prayerful advocates for the mission of God;
5. clearer about their vocation in the church and the world and therefore more determined to pursue personal and corporate lifelong learning as disciples of Christ;
6. open to the insights and challenges that emerge from serious engagement and cooperation with others, in and beyond the church.

3. Programme Learning Outcomes

LEVEL 4

Subject Specific Knowledge (SSK)

On successful completion of the level, students will be able to

1. discuss intelligently a range of biblical texts and various issues and methods related to their interpretation;
2. investigate and describe competently some major aspects of the Christian tradition and their development;
3. discuss knowledgeably some core aspects of Christian discipleship, such as worship, mission, spirituality or ethics, and the questions to which they give rise.

Subject Specific Skills (SSS)

On successful completion of the level, students will be able to:

1. identify the context and genre of selected biblical texts, and comment intelligently on their significance for the texts' interpretation;
2. engage in practices of Christian discipleship, mission and ministry in the light of theological and, where appropriate, other disciplines;
3. draw on appropriate methodologies and various relevant disciplines, with guidance from an experienced practitioner, to reflect on experience and practice in the context of discipleship, mission and ministry, and communicate this accurately and reliably in a range of contexts.

Key Skills (KS)

On successful completion of the level, students will be able to:

1. identify, gather and evaluate source materials for a specific purpose;
2. evaluate the appropriateness of different approaches, communicating their findings sensitively and respectfully, showing self-awareness about their own beliefs, commitments and prejudices;
3. carry out a guided task that involves: independent inquiry, management of time and resources; using IT; meeting deadlines; evaluating the task and learning from it;
4. recognise key issues in their own personal and professional development.

LEVEL 5

Subject Specific Knowledge (SSK)

On successful completion of the level, students will be able to:

1. engage in detail with selected texts of the Old and New Testaments in their cultural and religious contexts, analysing and using a range of approaches to interpretation, leading to an

ability to articulate the texts' significance for the church and world and the questions to which they give rise;

2. research and give a detailed account of aspects of Christian doctrine, ethics and church history in a range of historical and contemporary contexts, analysing significant developments and concepts;
3. describe practices of Christian discipleship, including mission and worship, analysing theological, ecclesial and contextual understandings of such practices and of the nature of discipleship, in relation to specific contexts in and beyond the church.

Subject Specific Skills (SSS)

On successful completion of the level, students will be able to:

1. apply different approaches to reading and interpreting biblical texts, communicating these with relevance and sensitivity to specialist and non-specialist audiences and contexts;
2. develop existing skills and acquire new competences and modes of inquiry in practices of Christian discipleship, mission and ministry, in the light of theological and, where appropriate, other disciplines, in new contexts;
3. draw on key aspects of relevant disciplines to begin developing a critical analysis of contemporary situations, reflecting on practice and experience, in the context of discipleship, mission and ministry, recognising the importance of knowing the limits of their knowledge.

Key Skills (KS)

On successful completion of the level, students will be able to:

1. identify, gather, analyse and evaluate textual source materials for a range of purposes;
2. undertake a critical analysis of information and arguments, communicating these effectively to specialist and non-specialist audiences, showing critical self-awareness of their own beliefs, commitments and prejudices;
3. take responsibility for a task that involves independent inquiry; the management of time, resources and use of IT; meeting deadlines; evaluating the task and learning from it;
4. plan their own personal and professional development.

LEVEL 6

Subject Specific Knowledge (SSK)

On successful completion of the programme, students will be able to:

1. engage in detail with selected texts of the Old and New Testaments in their cultural and religious contexts, making confident and critical use of them in the context of complex contemporary situations, and using and critically evaluating a range of approaches to interpretation.

2. research and give a coherent and detailed account of key doctrinal and ethical questions and the controversies surrounding them, explaining how they relate to aspects of faith, church and society;
3. describe and analyse theological, ecclesial and contextual understandings of the nature and practices of Christian discipleship, critically evaluating such practices in relation to a range of new contexts in and beyond the church;
4. demonstrate a systematic understanding of key concepts and processes of inquiry involved in the study of those disciplines selected for further study at Level 6, including critical engagement with some recent research methodologies and findings.

Subject Specific Skills (SSS)

On successful completion of the programme, students will be able to:

1. critically evaluate and apply different approaches to the close reading and interpretation of biblical texts, communicating these with relevance, rigour, creativity and sensitivity to a variety of audiences and contexts;
2. consolidate and extend competences and modes of inquiry in practices of Christian discipleship, mission and ministry in the light of theological and, where appropriate, other disciplines, in a range of complex and unpredictable contexts;
3. extend and apply their knowledge and understanding of key disciplines of theology, ministry and mission to new and complex contexts, reflecting critically on their impact on the life and ministry of the church, and showing sensitivity to the problems of religious language, experience, and the limits of knowledge.

Key Skills (KS)

On successful completion of the programme, students will be able to:

1. identify, gather, analyse and evaluate textual source materials, including material from primary sources and scholarly research, for a range of purposes, and communicate their findings with clarity and fairness using a variety of media to both specialist and non-specialist audiences;
2. critically evaluate ideas, arguments and assumptions, using them to construct and communicate coherent and well-reasoned arguments showing critical awareness of their own and others' beliefs, commitments and prejudices, to both specialist and non-specialist audiences.
3. take responsibility for an extended task that involves the exercise of initiative, independent inquiry, and the effective management of time, resources and use of IT; engaging with others in planning and decision-making in complex and unpredictable contexts; meeting deadlines; evaluating the task and learning from it.
4. take responsibility for their own personal and professional development.

(*) Students are advised that they are most likely to succeed in TMM3362 *Dissertation in Theology, Ministry and Mission* if their grades have been averaging B+ or higher in the current year. Please speak to your Fellowship Group tutor/tutor responsible for part-time students if you'd like some guidance on this.

6. Formative Assessment Policy

The College employs both formative and summative assessment methods to support student learning and measure achievement of programme learning outcomes.

- **Formative assessment** is developmental and provides students with an opportunity to practice skills needed for the summative assessments and to receive feedback on their progress. While indicative grades may be given, these assessments do not contribute to final module marks.
- **Summative assessment** formally evaluates students' attainment of learning outcomes through graded assignments, which contribute to the final module and qualification outcome.

Formative assessment methods vary by subject area and learning objectives and may include:

- Written work (exegetical papers, article evaluations etc.)
- Practical and reflective tasks (reflective portfolios, self-counselling projects, presentations etc.)
- Examinations and tests (language tests, regular language homework etc.).

Formative assessment plays a vital role in supporting student learning and development by providing opportunities to practise key skills required for summative assessments. This is particularly important in modules where summative assessment is limited to a single opportunity. Where a summative assessment is the sole measure of a module's learning outcomes, students must pass that component to successfully complete the module.

The use of formative assessment is guided by the following principles:

- To provide students with timely and continuous feedback that informs their preparation for final submissions.
- To foster student engagement and encourage active participation in the learning process.
- To help students consolidate their understanding and identify specific areas for improvement.
- To enable module tutors to gauge student progress early in the semester and adapt teaching strategies accordingly.

All assessments, whether formative or summative, are designed to uphold the principles of equity, ensuring fair opportunities for all students. This includes consideration of diverse educational backgrounds, individual learning needs, and prospective vocational pathways.

While it may not always be feasible to incorporate a dedicated formative assignment in every module, formative feedback from one module may positively impact performance in another, thereby contributing to students' overall academic development. As a general guideline, a maximum of one formative assignment is recommended for 10-credit modules, and up to two for 20-credit modules.

Formative assignments will not be awarded formal grades; however, students will receive written feedback within 3 weeks of submission to inform further learning.

In line with the recent development of new programmes under the Common Awards framework, a broader variety of formative and summative assessment formats has been introduced. This enhancement aims to improve undergraduate learning outcomes and better accommodate a range of learning styles.

7. Assessment Criteria

Common Awards have developed and published Assessment Criteria for each possible assessment component for all Common Awards programmes (in line with Durham University's generic assessment criteria and Level Descriptors). At Level 4 students are introduced to the core areas of subject specific knowledge, namely biblical studies, the Christian tradition and ministerial theology. The modules at this level offer a survey of subject specific knowledge to enable students to progress to level 5 within a clear framework for further study of theology, ministry and mission. Students are also introduced to the subject specific skill of relating their knowledge to experience and practice in the context of mission and ministry. This may take place in direct relation to the student's practical formation, or in interdisciplinary modules with a professional and/or denominational focus, or in other ways. In addition, students are introduced to the subject specific skill of theological reflection.

At level 5 students study the core subject areas at greater depth. The depth of study may take the form of a more focused area of subject specific knowledge and/or a more deeply contextual approach to an area of subject specific knowledge. Students will also broaden their study, for example ensuring that by the end of the level students will have engaged with a range of texts from both Old and New Testaments. Subject areas that were studied as interdisciplinary modules with a professional and/or denominational focus at level 4 will continue to be studied in this mode,

embodying a ‘spiral’ approach that enables increasing depth of learning in these subject areas.

Students will continue to hone subject specific skills at a higher and more critical level, engaging with more complex situations related to their profession and/or practice either through a short-term placement, through work-based learning or through a sustained placement that lasts throughout the student’s programme of study.

In addition, students will have the opportunity to study specialist subjects in areas such as inter faith engagement, environmental theology, science and faith and education, or to specialise further in a subject area. Students may offer an independent study module and/or an integrative learning module that further enhances the breadth of study available to them.

At Level 6 students will have a much greater degree of freedom in choosing specialist subjects. A dissertation or extended project ensures that students have an opportunity to demonstrate independent learning at this level. The project may be directly related to the practical element of the student’s programme or may involve research in practical theology.

Some students may choose a strong contextual and applied focus at level 6, as exemplified particularly by the group of modules entitled *Vocational and Professional Development*. This is the case, for example, for Church of England candidates who may proceed to level 6 as part of their curacy training. Educationally, these modules will ensure students harness the subject knowledge and skills that they acquired at levels 4 and 5 in greater depth, with greater independence, applying them in the ever more demanding and complex contexts of their ministerial and professional practice.

At all three levels, the programme offers students the opportunity to engage with their profession and/or practice either through short-term placements, through work-based learning or through a sustained placement that lasts throughout the student’s year or programme of study.

9. Overall Structure of the Programme

Award of Bachelor of Arts (BA Hons)

This programme leads to the award of a Bachelor of Arts with Honours (BA (Hons)) in Theology, Ministry and Mission. To be eligible for the award, students must successfully complete modules totalling 360 credits at Level 4 and above, achieving a minimum mark of 40% in each, including all compulsory modules.

The following table illustrates the credit distribution for the BA:

- A minimum of 120 credits must be achieved at Level 4.
- At least 90 credits must be completed at Level 5.
- At least 90 credits must be completed at Level 6.
- The remaining **60 credits** may be selected from optional modules, provided that all relevant prerequisites are met and timetabling allows:
 - In the DipHE stage: optional modules may be taken at Levels 4 and 5.
 - In the BA stage: optional modules may be taken at Levels 4 (Biblical languages only), 5, and 6.

Details of required modules for the DipHE Theology, Ministry and Mission are provided in **Section 10** below, and a comprehensive list of available modules (including codes and titles) is provided in **Appendix A**.

The first two years of the BA (Hons) Theology, Ministry and Mission programme correspond to the structure and content of the DipHE Theology, Ministry and Mission.

Mode and Duration and Study

The BA is normally completed over three academic years of full-time study, with each year comprising two semesters. A full-time study load typically includes 120 credits per year.

The first year of the BA Theology, Ministry and Mission programme is equivalent to the CertHE in Theology, Ministry and Mission. The second year is equivalent to the Diploma in Theology, Ministry and Mission. The programme may also be undertaken on a part-time basis, typically at a rate of 60 credits per year, although this may be varied with the agreement of the College.

The standard duration of registration for this programme aligns with the maximum permitted period: three years for full-time students and six years for part-time students. Students are expected to complete all academic requirements within this timeframe. Those experiencing extenuating circumstances that may impact their ability to do so should consult the Academic Registrar at the earliest opportunity.

Classification

The BA (Hons) in Theology, Ministry and Mission may be awarded either as a Pass (unclassified) or with an Honours classification (BA with Honours).

To be awarded the BA (Hons), students must pass modules totalling 360 credits at Level 4 or above, including all compulsory modules. These must include:

- At least 120 credits at Level 4 (CertHE level)
- At least 90 credits at Level 5 (DipHE level)
- At least 90 credits at Level 6 (BA level)
- An additional 60 credits, which may be taken at Level 4, 5, or 6

The final degree classification is calculated using only the grades achieved at Level 5 and Level 6. Grades from Level 4 are not included in this calculation.

The weighted average is determined as follows:

- Level 5 marks are weighted at 40%
- Level 6 marks are weighted at 60%

Final classifications are awarded according to the following scale:

- First Class Honours: 70% – 100% overall average
- Upper Second Class Honours (2:1): 60% – 69% overall average
- Lower Second Class Honours (2:2): 50% – 59% overall average
- Third Class Honours: 40% – 49% overall average

Compensation Regulations

Compensation of up to **40 credits** across Levels 5 and/or 6 is permitted for the BA. Compensation may be applied provided that:

- A student has achieved a minimum mark of 30% in the module(s) to be compensated;
- A student has maintained an overall average of at least 40% across all Level 5 and 6 modules (these marks will be combined using a 2:3 weighting, with Level 6 marks being weighted higher);
- The achievement of the learning outcomes is not compromised by failure in the module(s) concerned. The regulations for each programme indicate which module(s) may not be passed by compensation because failure in those modules would compromise the achievement of the learning outcomes of the programme (e.g. the dissertation & project modules).

Exit Points and Progression Beyond the BA (Hons)

Students enrolled on the BA (Hons) Theology, Ministry and Mission programme who leave the College before completing all 360 credits required for the full award may be eligible for an alternative qualification, depending on the number of credits successfully achieved:

- A student who has completed 60 credits may be awarded a Foundation Award.
- A student who has completed 120 or 180 credits, including all compulsory modules within that credit total, may normally be awarded a Certificate of Higher Education (CertHE).
- A student who has completed 240 credits, including the required compulsory modules, may normally be awarded a Diploma of Higher Education (DipHE).

Credits earned below these thresholds may be formally recognised and may be applied to future academic programmes, subject to relevant APL (accreditation of prior learning) regulations. In all cases, students will receive official confirmation of the credits attained.

Students may also choose to extend their studies prior to the conferral of the BA (Hons), in order to pursue a higher qualification. Students wishing to apply for postgraduate study—such as a Postgraduate Certificate (PGCert), Postgraduate Diploma (PGDip), MA in Theology, Ministry and Mission, or MA in Contemporary Christian Leadership—are encouraged to submit their application before the end of their third (BA) year.

12. Pre/Co-requisites within the Programme

13. Admissions Criteria

a. Academic requirement

- Normally a minimum of three A-Levels (grade E or above) or equivalent.
- Graduates in other subjects may enter the BA programme.
- Students who have successfully completed the Common Awards Diploma in Theology, Ministry and Mission may be admitted to Level 6 of the BA programme.

b. Non-standard admission

Applicants not meeting the standard academic entry requirements (e.g. not having an A-Level or equivalent qualification) will need to demonstrate their potential to benefit from the chosen programme. This will be assessed in the following ways:

- Assessment of how work and life experience and academic performance to date, may help with the programme.
- Submission of recently completed assessed work or completion of a piece of work set by Oak Hill during the selection process.
- Approval from the University of Durham (if Oak Hill wishes to offer a place to an applicant).

c. English language requirement

Applicants whose first language is not English must satisfy the College that they have a sufficient command of spoken and written English to meet the demands of their chosen programme.

IELTS Academic or equivalent is required for the BA: **6.5 overall** with no less than 6.0 in any component. More information about equivalent English Language qualifications can be found on the College website (see '[Study with us](#)' on the website).

An applicant will be considered to have satisfied the English language requirement if they have successfully completed a UK Bachelor's degree or higher, or an equivalent qualification, taught and assessed in English in a majority English-speaking country.

d. Accreditation of Prior Learning (APCL)

In general, up to a maximum of 120 credits of accredited prior learning may be granted to students who have evidence of, or can demonstrate learning that fulfills the relevant learning outcomes of the BA programme (by completing a portfolio of work, for example).

Graduates in other subjects may enter the BA programme. Students who have completed 120 credits of ministerial theology at level 4 in another institution may be considered for exemption from the first year of the BA programme through APL. For more information about APL, please refer to the College *Admissions Policy*.

14. Field Trips, Placements and Future Careers

All students will have taken part in a Weekly Church Placements during the CertHE and DipHE year (TMM1437 and TMM2321), with the nature of the placement tailored to the training needs of the student: for example, whether they are an Independent or Anglican student or whether they are training for ordination in the Church of England. Assessment of each placement will be by means of a portfolio of reports and reflections on personal goals and learning.

All of the College's programmes are vocational and are intended to equip students with the necessary knowledge, skills, experience, attitudes and characteristics for Christian ministry of various types (for example church leadership, pastoral ministry, women's ministry, cross-cultural work, youth work, etc: these, alongside our beliefs and values, are set out in detail on the [College's website](#)).

Personal tuition throughout the BA year provides support in all areas of the student learning experience. This includes ongoing guidance on the academic programme and on future career possibilities, as well as regular Personal Development Planning activity. Placements in local church settings also allow students the opportunity to create connections with possible future employers, and with those who are involved in the relevant work field.
